- 1) Applicants/vehicle owner should submit a DD/BC of Rs.1000/- drawn in favour of Northern Coalfields Limited, Bina Project payable at S.B.I. Bina, Sonebhadra, U.P. ( Branch Code-03441) as application fee. The above fee is non-refundable. Further, only those people are eligible for apply having at least one commercial vehicle. Application without registration fee shall be rejected.
- 2) Vehicle provider who comply the following criteria shall be eligible to quote : ----
  - i) Person offering the vehicle should have at least one tendered vehicle.
  - ii) The vehicle to be deployed should be registered in UP only.

  - iv) Pollution clearance certificate.

- vi) Valid UP & MP Taxi permit as applicable to ply the vehicle in UP & MP.
- vii) Valid driving licence with address and driver must have minimum 03(three) year experience.
- viii) Service Tax Registration if applicable.
- ix) NCI Vendor code, if available.
- x) PAN card issued by IT Deptt.
