- 1) Applicants/vehicle owner should submit a DD/BC of Rs.1000/- drawn in favour of Northern Coalfields Limited, Bina Project payable at S.B.I. Bina, Sonbhadra, U.P. (Branch Code-03441) as application fee. The above fee is non-refundable. Further, only those people are eligible for apply having at least one commercial vehicle. Application without registration fee shall be rejected.
- 2) Vehicle provider who comply the following criteria shall be eligible to quote -----
 - i) Person offering the vehicle should have at least one tendered vehicle.
 - ii) The vehicle to be deployed should be registered in UP only.
