

Quotation will be received up to 04:00 PM on 05.06.2019 and the same will be opened at 04:30 PM on the same day in presence of tenderers or their authorized representatives, who may like to be present at the time of opening. Earnest Money Deposit (EMD) of the amount as shown in quotation notice should be in the form of crossed demand draft/banker's cheque drawn in favour of Northern Coalfields Limited, Block-B Project payable at State Bank of India, Gorbi / Singrauli submitted along with sealed quotation.

Quotationers should submit the following documents at the time of offering their rates :

1. Latest income tax clearance certificate/PAN.
2. Proof of proprietorship / partnership deed / power of attorney.
3. Experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following: -
Three similar completed works each costing not less than the amount equal to 40% of the estimated cost OR (b)
Two similar completed works each costing not less than the amount equal to 50% of the estimated cost OR (c)
One similar completed work costing not less than the amount equal to 80% of the estimated cost.
(Similar means-Installation of CCTV /GPS System).
4. GST registration certificate.
5. PAN based vendor code is to be indicated. In case of non availability of same , filled form for issue of PAN based vendor code is to be submitted along with quotation(Annexure-A)
6. Average annual financial turnover during the last 3 years, ending 31st March of the previous financial year, should be at least 30% of the estimated cost.
7. **BOQ should not be handwritten, it should be typed.**
Terms and conditions :
 1. Payment : 90% payment will be made within 21 days from the date of acceptance of bill and after successful completion of work in all respect balance 10% will be released to the contractor after 12 months of successful completion of work(Guarantee period) in all respect.
 2. Management reserves the right to accept or reject any tender or divide the work among two or more tenderers without assigning any reason whatsoever.
 3. LD : ½% per week or part thereof, for the delay, subject to a maximum 10% of the total awarded value.
 4. Completion : The job should be completed within 30days counted from the date of issue of work order for the work or actual date of handing over the site/equipment whichever is later.
 5. Validity of offer : The offer / quotation shall remain valid for a period of 120 days from the date of opening of bid.
 7. No postal transaction will be accepted for obtaining / submission of tender documents.
