

- iii) The bidders/tenderers have to furnish the details of their Bank A/c. Nos. Name of the Bank, Address of the Bank and Branch code as mentioned in Annexure B.
- v) An affidavit on non judicial stamp paper (sample of affidavit is provided in this vehicle hiring document in Annexure A) has to be submitted by the Vehicle Owner.
- vi) Copy of Permanent Account No. (PAN) issued by income tax department.
- vii) Copy of valid GST.
- viii) Credentials duly authenticated by the bidder, in support of his/her qualifications in accordance with the eligibility criteria ,Point no.11 of vehicle hiring document.

Envelope No.2 shall contain Discount Bid Format .Both the envelopes should be super scribed with notice no. for which discount bid offered. Completed bid should be dropped in the tender box kept in the office of Staff Officer (E&M), Khadia Project **up to 11.00AM dated 28.05.2019** which shall be opened at **11.30 AM dated 28.05.2019**. Issue of the discount bid format shall not automatically mean that bidders are considered qualified to undertake such work.
