

NOTICE FOR SUBMISSION OF DISCOUNT BID FOR HIRING OF LIGHT VEHICLES



Sealed discount bids in single envelope are invited from the vehicle owners registered at Nigahi Project for hiring of the following light vehicles :-

1. The Discount Bid Format can be obtained free of cost from the office of the General Manager (E&M), Nigahi Area from 18.07.18 to 02.08.18 on all working days from 10.00 AM to 4.00 PM. Offer should be submitted in sealed envelope containing earnest money, other documents / papers and Discount Bid Format. The envelopes should be superscribed with notice no. and date. Completed bid should be dropped in the tender box kept in the office of GM(E&M), Nigahi up to 11.00 AM on 03.08.18 and the offer will be opened on the same day at 4.30 PM. Issue of the discount bid format shall not automatically mean that bidders are considered qualified to undertake such work. Offers submitted after schedule time will not be entertained in any cost.
2. Earnest money should be furnished through Demand Draft / Banker's Cheque / Pay Order in favour of Northern Coalfields Limited, Nigahi Project payable on Union Bank of India or State Bank of India, Nigahi. Offers not accompanied with earnest money are liable for outright rejection. Earnest money payable at any other branch of nationalised bank operating with Singrauli Coalfields will have to include an additional realisation and service charges of Rs. 200.00 per Rs. 20,000.00 or part thereof. The earnest money will be retained in case of successful bidder and will not carry any interest.
3. EMD shall be considered for exemption to the Project Affected People (PAP) as preference to them on submission of relevant documents.
4. a) If the L1 bidder does not offer for the entire quantity of vehicle required as per NIT, provision may be made for offering counter offer with L1 rate to the other bidders (Subsequent to L1 i.e. L2, L3.....) for balance quantity of vehicles required till the entire requirement is met.
b) If L1 rate is offered by more than one bidder, L1 status shall be considered on the basis of latest model (in terms of date of Registration) for award of work.
5. a) Shortfall documents will be sought giving 10 days time from the L1 bidder if the document submitted by the bidder has some deficiency as per requirement of the NIT. In case of L1 bidder fails to submit requisite document EMD submitted by the bidder shall be forfeited and subsequent offer shall be considered for evaluation.
b) Same procedure shall be adopted in case of evaluation of offer of L2 and subsequent bidders in case of offering with the L1 rate.
6. No postal transaction shall be accepted for obtaining/submission of quotation documents.

 - xi). General Terms & Conditions duly accepted. (To be collected from office).
 - xii). Any document for the proof of Legal Status of bidder i.e. Proprietorship / partnership / Limited Company / Joint Venture / individual.
