NOTICE INVITING APPLICATION FOR REGISTRATION OF VEHICLE OWNER FOR HIRING OF COMMERCIAL LIGHT VEHICLES FOR NSC JAYANT

Eligibility Criteria: Applications/Vehicle Owner should submit a DD/BC of Rs.1000.00 drawn in favour of NCL,NSC payable at State Bank of India Nigahi(branch code 14958) In case the Bank Draft is submitted through any other Nationalized Bank or payable at any outstation branch, then the realization/service charge of Rs.200/- per Rs.20,000/- is to be paid extra or part thereof along with the application form as application fee. The above fee is non-refundable. Further, only those people are eligible for apply having at least one commercial vehicle. Application without registration fee shall be rejected.

Availability of forms: The application forms/documents may be obtained free of cost from the office of Staff Officer(P),NSC from 10.04..2017 to 17.04..2017 and duly filled application will be received upto 18.04.2017 till 4 pm.
