

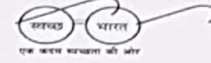

The above fee is non-refundable. Further, only those people are eligible for apply having at least one commercial vehicle. Application without registration fee shall be rejected.

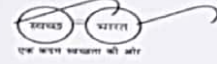
