Important: The offer is to be submitted to the office of SO (MM), NSC, Jayant in two covers. Cover I should contain the notarized & self-authenticated copies of eligibility, other required documents with EMD along with acceptance of Terms & Conditions of Quotation notice and Cover II should contain the Annex I duly filled & signed/sealed on the letter head of the Firm/Bidder/ Supplier.

Cover I will be opened first and after scrutiny and qualifying of offer as per quotation notice submitted in cover I, cover II will be considered for opening.

Offer Submitted in single cover will not be considered for opening. Offer with any conditional acceptance of terms of Quotation notice will not be accepted/ considered for evaluation.

Terms & Conditions:

Period of Operation of Contract : One Year.

Estimated approximate Off-take value of the contract for 01 year: Rs.75 lakhs

Value of EMD: Rs.1.50 lakh

Bidder has to submit EMD value of Rs.1.50 lakh in the form of Bank draft in the favour of " NCL, NSC" payable at State Bank of India, NIGAHI BRANCH (without collection charges) Branch Code-14958. Other demand Drafts drawn on any other nationalized bank of Singrauli/ Morwa locality should have an additional collection charge of Rs.200/- for every Rs.20,000/- or less.

Exemption from submission of EMD& SD:

a) State/ Central Govt. Organizations/ PSU & valid DGS&D (registered for the tendered items) are exempted from submission of **EMD&SD**.

For this purpose, DGS&D firms will have to submit the scanned & notarized photocopies of complete valid registration certificate with DGS&D for tendered items.(valid as on date of opening of tender).

- b) Valid ancillary units of Northern Coalfields Limited are also exempted from submission of **EMD & SD** for the items for which they have been provided ancillary status from NCL.
- c) NSIC registered firms (registered for the tendered items) are also exempted from submission of **EMD only** for the items for which they have registered.
For this purpose, NSIC firms will have to submit the scanned & notarized photocopies of complete valid NSIC Registration Certificate with the list of tendered items.
- d) For procurement value less than Rs.1.00Lac, no EMD/SD will be required.
- e) Bidders having **MSE** registration certificate issued by the competent Govt. bodies are exempted from **EMD** submission.

Note A: EMD shall be forfeited, if any tenderer withdraws their offer before finalization of the tender.

Note B: In case of exemption claimed by the bidder for the EMD, Notarized and Self-Authenticated documents in support of exemption has to be submitted along with offer. Offer submitted without EMD and proper exemption certificate will be treated null and void (in case EMD is not submitted).

Note C: Offer of the Firm will not be considered for evaluation if offer is not submitted along with requisite EMD value.

Eligibility :

- (i) **Locality:** The Supplier/Firm should be locally situated.
- (ii) **Drug License:** Supplier/firm should have Valid Drug License.
- (iii) **TIN:** The firm must have valid TIN No.

Notarized and self-authenticated copy of documents related to eligibility is to be enclosed with offer.

Requirement: Requirement will be on SOS basis and will be issued in GENERIC NAME. Generally requirement will be sent twice a day, one in the morning and other in the evening.

Supplies: The Items to be supplied should be of reputed companies.

Delivery: Delivery should be firm and FOR Destination basis. Supply is to be made within 24hrs preferably within 12hrs of receipt of Supply Order.

Guaranty / Warranty: All cases of warranty replacement will be decided on the basis of joint inspection of the failed goods held between the user representative and the supplier's representative. Tenderer shall be fully responsible for the manufacturer's warranty in respect of quality of the material. The treating Doctors if not satisfied with the quality of the materials supplied, it will be returned back immediately within 24hours and the firm/ supplier/ tenderer will replace the material/item free of cost with in 24hrs.

VAT/Sales Tax: The firm should quote Maximum Percentage of flat discount over MRP (Maximum Retail Price). No VAT/Sales Tax or any taxes should be charged extra.

Payment: Bank payment within 21 days of receipt of supplies or the invoice whichever is later.

Confirmation : Firm should confirm acceptance of all terms and conditions.


All documents submitted should be self-attested with seal of the company.
