NOTICE

Sub: Deposition of the price differential arising out of revision in notified price for all e-auctions having flexible lifting period / extended lifting period.

All the Buyers / Customers taking coal under Special forward e-auction for Power & Exclusive e-auction for non-Power are hereby informed that as per the direction issued by GM (M&S), CIL, Kolkata vide letter no. CIL/M&S/E-Auction/95 dated 15.02.2018, all the Coal Companies are required to charge/realise the price differential arising out of revision in notified price for lifting / booking under Special forward e-auction for Power & Exclusive e-auction for non-Power having flexible lifting period / extended lifting period.

As per the direction of CIL, Coal Companies are required to charge/realise the price difference, for any despatches against Special Forward e-auction and Exclusive e-auction, pursuant to revision in the notified price, also that if the successful bidder wishes to cancel their pending orders / booking against auction conducted prior to such price revision and are yet to lift the quantity, may be allowed to cancel the same without any forfeiture, after adjusting dues if any. Last price revision at NCL has taken place w.e.f. 09.01.2018.

In view of the above, concerned consumers (a) who have lifted coal from NCL w.e.f. 09.01.2018 under Special forward e-auction for Power & Exclusive e-auction for non-Power & (b) who have pending orders for booking / lifting, under Special forward e-auction for Power & Exclusive e-auction for non-Power of NCL are required to pay the amount pertaining to price differential arising out of revision in notified price w.e.f. 09.01.2018. The amount already due may kindly be paid before fifteen (15) days i.e. by 05.03.2018 failing which action as per the auction scheme shall be taken.

If the consumers / successful bidders do not want to pay the price differential arising out of revision in notified price and instead wishes to cancel their pending orders / booking against Special forward e-auction for Power & Exclusive e-auction for non-Power conducted prior to such price revision and are yet to lift the quantity, such consumers may submit their request for cancellation of pending orders / booking in writing to this office for considering such request.

Consumers may kindly contact Sr Manager(Finance/Sales), NCL HQ for further clarification regarding the details of consumer wise additional amount arising out of the price differential pursuant to revision in notified price for supply under Forward e-auction for Power & Exclusive e-auction for non-Power having flexible lifting period / extended lifting period.
