
Sub: Deposition of additional statutory dues a/c DMF from 12.01.2015 (UP Projects)

All the customers buying coal under Special forward e-auction for Power / Exclusive e-auction and linkages/FSAs are hereby informed that as per the Gazette notification no G.S.R 837(E) dt 31.08.2016 of Ministry Of Coal, Govt Of India, contribution towards District Mineral Foundation(DMF) is payable on Coal w.e.f.12.01.2015.

As such all the concerned consumers who are booking coal under Special forward e-auction / Exclusive e-auction and linkages/FSAs are here by informed to deposit the coal value at the revised rates inclusive of all statutory dues a/c contribution to DMF also.

Since the contribution towards DMF is to be paid with retrospective effect from 12.01.2015, project wise details of arrears to be deposited by customers who have drawn coal under Special forward e-auction / Exclusive e-auction and linkages/FSAs is readily available at our website www.nclcil.in for reference to the customers.
