

Procedure Order for releasing Allotment of coal rakes.

Office Order No. 1/2014

Sub: Procedure order for releasing allotment of rakes for loading of Coal over Dhanbad Division.


1. The Coal Company as well as other Sponsorer will have to submit their offer on day to day basis clearly specifying the name of loading point/siding and destination along with the name of consumers. Allotment will be released as per the offer made indicating the directional seniority for supply in case of NC rakes only. However, destination offered for Core Sector Power Houses can be changed.
2. Allotment for Friday and Saturday will be released on Thursday and for Sunday and Monday on Friday. In case of holidays, allotment will also be released in advance.
3. Offer for allotment will be received up to 11.45 Hrs. Offer submitted can be withdrawn only before the allotment is released.
4. Allotment will be released by the Railways without indicating the type of coal to be loaded.
5. No allotment will be released if a destination is under restriction. Information regarding imposition of restriction available up to 13.00 hrs. of the date of release of allotment will be taken into account as the latest status of destination being restricted.
6. There will be no provision for keeping an allotted rake in abeyance. However, the Sponsorer may consider cancellation of allotment in case despatch is not to be effected.
7. Request for cancellation of allotted/un allotted rakes should only be accepted from the Sponsorer only and not directly from the consumers. Cancellation of allotted rakes will be accepted only if the rake has not yet been supplied for loading. Part cancellation of rake will not be allowed. Rakes once cancelled will not be revived under any circumstances. Request for cancellation shall be received up to 16.00 hrs. on any working day.

8. Allotment of Non Core Rakes including CPP and E-auction will be released indicating the directional seniority for determining sequence of supply till such time necessary provision for releasing allotment is not made in the RAS Coal Module. In case of Core Sector Power Houses, date of allotment will determine the seniority for supply. When more than one allotment is released in a particular date from a particular siding a/c Core Sector Power Houses including IPP, supply will be made depending upon the operational convenience.
9. **When the arrears of Non Core Rakes including CPP of a particular Siding/Pilot reaches up to 8 times of particular siding's average daily loading performance of last month, releasing of allotment of Non Core Rakes will be stopped to restrict further accumulation of arrear. However, this limit may be revised at a later date. This clause will not be applicable to PPH and IPP rakes.**
10. No change of destination will be allowed once a rake is supplied for a particular destination. The Coal Company is not authorised to change the destination of the rake supplied for a particular destination.
11. Allotment will be treated cancelled under the following circumstances:
  - (a) When the rake is supplied for loading but the siding holder does not commence loading before the expiry of the free time allowed.
  - (b) When the rake is supplied for a particular destination but the Coal Company on its own loads it for other destination.
12. Once an allotment is cancelled, the rake can be supplied to some other destination having valid allotment.
13. The above procedure orders shall be reviewed from time to time as per necessity.
14. **This procedure order will come into force with immediate effect and shall remain valid till further advice along with its amendments, if any, to be issued from time to time.**


