**NOTICE FOR THE CONSUMERS THOSE WHO HAVE EXECUTED FSA WITH NCL**

It is brought to the notice of all consumers having executed FSA with NCL that as per clause No. 3.4 of Fuel Supply Agreement (FSA) the value of Security Deposit (S.D.) is required to be suitably increased/decreased to match the changes in the base coal price notified by NCL/CIL from time to time.

In view of the recent coal price revision as per CIL Notification w.e.f. 00.00 hrs of 27.02.2011, the amount of additional S.D. is required to be deposited within 30 days by way of additional Bank Guarantee/ Demand draft as per the details enclosed herewith. The period of validity of such Bank Guarantee shall be same as the initial S.D. Bank Guarantee furnished at the time of execution of FSA. Alternatively the amount of S.D. Bank Guarantee may be increased by an amendment so as to cover the increased value of S.D. resulting from such change in the base price.

In case of failure of depositon of additional S.D. amount within thirty(30) days, NCL shall have to right to suspend the coal supplies as per the terms of FSA.
